# Hull and East Yorkshire Volleyball Association

## Constitution

- 1a. The name of the Association shall be the Hull and East Yorkshire Volleyball Association (H&EYVA)
- b. The Association, its clubs and players shall be affiliated to Volleyball England (V.E.)
2. The objectives of the H&EYVA shall be:-
  - a. To encourage, in every way the game of volleyball within the old Humberside boundaries.
  - b. To interpret the rules and regulations as published by V.E.
  - c. To act as the governing body of volleyball within Hull and East Yorkshire.
  - d. To represent Hull and East Yorkshire Volleyball nationally.  
Team members must be affiliated to H&EYVA
  - e. To co-operate with all appropriate bodies in matters which could further these objectives.
- 3a. Membership of the Association shall be open to properly constituted Clubs within the old Humberside boundaries.
- b. A properly constituted Club must have :-
  - (i) an elected Chairman
  - (ii) an elected Treasurer
  - (iii) an elected Secretary
  - (iv) a Fixture Secretary for each team
- c. The names and contact details of all these officials should be forwarded to the H&EYVA on registration of the Club.
- d. Any changes in these officials should be forwarded to H&EYVA at once.

- 4a. Registration procedure shall be laid down by the “Executive Committee” of the H&EYVA
- (i) Each team must pay a £30 deposit to the H&EYVA on registration of their club. This is refundable at the end of the season on a representative from the team attending the Annual General Meeting A.G.M.) One person can only represent one team.
  - (ii) Each team must pay a £80 (*£25 if all registered players except one coach are under 18 years old*) non-returnable entry fee to the league.
- c. Annual fees payable to the H&EYVA shall be laid down by the “Executive Committee” for approval at the A.G.M. prior to the playing season.

- d. All teams in the league have to nominate at least one referee to the Officials Secretary (if one in place.) The nominated referee’s details will be made available to all teams in the league with a view to refereeing official H&EYVA fixtures for any club. It is encouraged that every referee should be registered with the V.E.
- 5a. The H&EYVA shall be administered by an “Executive Committee” elected annually at the A.G.M., or at a General Meeting called for that purpose.
- b. If possible, the “Executive Committee” shall comprise the President, Vice-President, Chairperson, Honorary Secretary, Honorary Treasurer of the H&EYVA together with 8 Committee Members who shall have the following responsibilities:-
- Cup Competitions Secretary
  - League & Fixtures Secretary
  - Publicity Officer
  - 2 Members without portfolio
  - Junior Development Officer
  - Officials Secretary

- 5c. The “Executive Committee” may co-opt up to 3 non-voting members.
- d. (i) The “Executive Committee” shall meet twice a season if possible,  
(ii) There will be 3 compulsory meetings through the year, the dates of which will be set at the A.G.M. Every team must send a representative. Failure to attend for the duration of the meeting will result in a fine of £10 per meeting and this will be deducted from the £30 deposit. Each team will have 1 vote at these meetings.  
(iii) The Minutes of the previous meeting and the current Agenda should be sent to all “Executive Committee” Members 7 days prior to the date of the Committee Meeting.
- e. At least 3 of the possible 12 voting Committee Members should be present for a Committee Meeting to be quorate.
- f. Any member of the “Executive Committee” absenting themselves from 3 consecutive meetings without reasons considered adequate by the other members shall be deemed to have retired.
- 6a. The Annual General Meeting of the H&EYVA shall be held on a date to be confirmed.
- (i) Each registered team must send at least one representative to the A.G.M.
- (ii) Voting at the A.G.M. shall be the right of each Club as follows:  
One club representative plus an affiliated team representative.  
*(Thus a club with 1 team has 2 votes; one with 2 teams has 3 votes, etc.)*
- b. The Honorary Secretary or Chairperson shall give at least 14 days clear notice of the time and place of the A.G.M. This should be sent via e-mail to the secretary of each registered team.
- c. The statement of finances shall include transactions up to and including 20<sup>th</sup> April of the current year and should be audited by two members of the Association elected as Honorary Auditors at the previous A.G.M.
- d. The Statement of Finances should be approved at the A.G.M.
- e. A General Meeting or an “Executive Committee” Meeting may be called, at any time, on a requisition signed on behalf of not less than 4 teams registered to the H&EYVA

- 7a. Rules of Competition within the Association shall be formulated by the “Executive Committee”.
  - b. Any alterations or additions to these rules may be made only at the A.G.M. or at a General Meeting called especially for that purpose.
  - c. Details of such alterations or additions must be forwarded, in writing to the Honorary Secretary of the H&EYVA not less than 14 days prior to the A.G.M. or General Meeting.
- 8a. Any alterations or additions to this Constitution shall be made only at an A.G.M. or at a General Meeting called especially for that purpose.
  - b. Details of proposed alterations or additions must be forwarded in writing to the Honorary Secretary not less than 14 days prior to the A.G.M. or General Meeting.
9. The Volleyball League season will normally start in the first full week in October and finish in the last full week in April.

## *RULES OF COMPETITION*

### GENERAL CONDITIONS OF PLAY FOR ALL COMPETITIONS

#### **A. Players and Registration**

1. All teams must be affiliated to H&EYVA and Volleyball England as laid down in the Constitution.
- 2a. All players must be registered members of a H&EYVA registered team 7 days before playing in any competition. Registrations should be done using the online registration system.
- b. All club secretaries are provided with a verbal instruction guide and demonstration of how to use the online system before the fixtures meeting. The signing on electronic template includes a space for player's name, and a player photograph. Teams are encouraged to try and process as many players as possible at the league fixtures meeting to avoid emergency or 7 days sign-ons.
3. A player may register at any time up to the 31<sup>st</sup> March by following the registration procedure. Teams should endeavour to have all players signed by the last day in October each season. Players signed after this date will be charged £3 for signing late. University teams due to their dynamics will only be charged £3 per player after the last day in December.
- 4a. Players may transfer between teams if they wish
- b. All transfers must be approved at an "Executive Committee" Meeting or failing this, the Chairman and Secretary.
- c. No player may transfer to another club after the 31<sup>st</sup> December for the remainder of the season.
- d. To effect a transfer the League Secretary must have: -
  - (i) A e-mail/etter from the player requesting a transfer.
  - (ii) An e-mail from the club he/she is joining, accepting the transfer.
  - (iii) An e-mail from the club he/she is leaving, granting transfer unless waived by the "Executive Committee".

4e. No transfer shall be effective until the League Secretary has informed the player's new club of completion of transfer.

5. Where a club has more than one team:

When a club enters more than one team, it must name an A and a B team. The club must asterisk (on the website) five of its best seven players. These five players may only play in the 'A' team; the remaining players may play in any team at any time. This means that two high quality players can still assist with the development of the B team. The Chairman will negotiate the best five players with a club if a complaint is made by another club before the season starts. The five players cannot be rotated throughout the season.

6a. Any team which is not correctly registered, or plays an incorrectly registered player, shall default AUTOMATICALLY. Points gained by the other team for that match shall stand. The League Secretary is responsible for this.

b. Any transfers during the season will be published via e-mail by the league secretary.

7. In order to assist with accurate officiating, it is compulsory that when playing in the league and cup competitions, each team has an identifiable same colour shirt which is numbered at least once. Not doing so, incurs a fine of £5 per player in each game. Persistent offenders will be discussed at the committee meeting, and the committee will decide if a point's deduction is necessary. It is the responsibility of the opponents and the match referee to ensure that incorrect kit is recorded on the scorecard. Libero players must wear a differently coloured shirt, also with a number.

## **B. Timing of Fixtures**

1a. The first referee should be present 15 minutes before the arranged start time to supervise the official warm up.

b. The match court should be available for the official warm up.

c. The official warm up should start 15 minutes before the arranged start time.



- 2a. In the event of late arrival of players, no postponement of the arranged start time will be allowed for warm up purposes.
- b. In the event of a team being incomplete 15 minutes after the arranged start time, that team shall default the match.
- c. In these circumstances the defaulting side shall be liable to a fine by the “Executive Committee” of not less than the referee’s fee. £10.

**C. Rules of Play**

- 1. The relevant Official Rules of Volleyball which refer to the Players and Officials shall apply at all times.
- 2a. The “Executive Committee” shall have the right to suspend the registration of any player who offends persistently against any relevant rules.
- b. Breaches of Discipline recorded on score cards (i.e. ALL CARDS) shall be reported to the “Executive Committee” by the Secretary to whom the card is sent.
- c. A “point system”:-
 

YELLOW CARD	=	1 POINT
RED CARD	=	3 POINTS

 shall operate.
- d. A player reaching 3 points in total shall be deemed a ‘serious offender’ (see 2a above).
- e. A player liable to suspension shall be informed by the Honorary Secretary of the date of the meeting at which the suspension will be discussed, giving right of appeal.
- f. If a player is suspended from playing, League and Cup matches shall be treated as the same.

**D. Court and Equipment**

- 1. The playing area and equipment should conform as closely as possible to the standards laid down in the relevant Official Rules of Volleyball. In particular:-

- (i) The NET is at a height of 2.43m at the centre of the playing court. The net height over the two sidelines must not exceed the official height by more than 2cm. The net must be equipped with antennae.
  - (ii) The BALL should carry the FIVB approved logo. If the away team are able to supply a better FIVB or similar ball than the home team, then this should be used for the match
  - (iii) The COURT must be 18m long and 9m wide.
- 2a. Each club, when registering with the H&EYVA should give details of their home venue in writing – address, type of court (gym, sports hall, etc) and normal times of fixtures. The start times must be between 6:30pm and 9:00pm Monday to Friday or 9:00am and 9:00pm Saturday and Sunday. A team must be able to fulfil the obligation to provide a home venue. Teams must keep their contact and venue details up-to-date on the school website.
- b. Should the home venue provide a court which:-
- (i) is not of standard dimensions.
  - (ii) has any special features involving ‘LET’ decisions, such anomalies should be mentioned on the completed registration form and sent to the H&EYVA
  - (iii) Obstacle ‘Let’ Clarification - Low hanging obstacles within the length and width of the volleyball court are classed as a “let.” Team coaches/captains should discuss with the referee before the match what counts as a low hanging obstacle if deemed appropriate. The roof may be counted as a low hanging obstacle if not regulation height or over.

Specifically for the H&EYVA league – venue: South Holderness School. All low hanging objects such as ropes and hanging beams are counted as a let. The roof is a point to the opposition.

## **E. Disputes Procedure**

1. The “Executive Committee” is responsible for resolving all disputes in the best interest of the H&EYVA
2. (i) The protest must be made to the first referee BEFORE (*if possible*) the start time of the match (before the end of the official warm up).
- (ii) The first referee must record the protest on the scorecard and sign the protest at the time.

- (iv) Both captains must sign the protest at this time.
- (v) The match shall then be played as normal.
- (vi) The completed scorecard should be sent to the relevant Secretary.
- (vii) A written statement of the complaint must be sent to the Honorary Secretary and a copy sent to the Secretary of the other team giving right of appeal to the “Executive Committee”. Complaints and appeals must be received within 10 days of the fixture.
- (viii) A Complaints and Disputes Committee shall be held comprising three members drawn by lot (in the presence of Chair, Honorary Secretary and one other Committee Member) and shall be chaired by the Honorary Secretary). The Chair and Cup/League Secretary and complainant should be invited to attend to aid with the work of the Committee.
- (ix) An appeal may be made against a decision made by the H&EYVA Complaints and Disputes Committee within 10 days of notification of its outcome.
- (x) An Appeals Committee will comprise of three other members drawn by lot (in the presence of the Chair, Honorary Secretary and one other Committee Member) and shall be chaired by the Chair. The Honorary Secretary and Cup/League Secretary are exempt from this draw however they may be invited to attend, with complainant, to aid with the work of the Committee.
- (xi) Both the Complaints and Disputes Committee and the Appeals Committee reserve the right to sit “in Camera”.

**There is not right of appeal against a ruling made by the “Executive Committee” on a dispute.**

3. Disputes over any other aspects of a match should follow stages (v)-(vi) above.
4. In resolving a dispute, the “Executive Committee” shall have the power to:-
  - (a) Uphold the result.
  - (b) Order the match replayed.
  - (c) Arrange a replay, with expenses shared between the two teams.
  - (d) Award the match to the protesting party.

## **F. Officials**

1. Home teams must provide a non-playing official at each match in addition to the minimum six players.
2. Away teams should provide an official, who should be non-playing where possible.
3. It is the responsibility of the inviting Secretary to remunerate the first official a minimum of £10 and the second official a minimum of £4, payable before the commencement of the official warm up.
4. If the non-playing officials are qualified the one provided by the Home team shall be the first referee.
5. If both non-playing officials are qualified the one provided by the Home team shall be the first referee.
6. If the Away team's official is a player, the non-playing official shall be the first referee, even if unqualified.
7. Although at times it is hard to find/pay referees, if not qualified, the referee must be someone who knows all of the Volleyball rules, including any recent additions. If a home team is struggling to find a suitable referee, then one of their more experienced players/referees must referee the game instead, rather than somebody who isn't fully aware of FIVB rules and developments. Where possible, the away team should try to provide a second referee. Not doing so, weakens refereeing decision arguments.

## **A. LEAGUE FIXTURES**

### **Fixtures Procedure**

#### **Arranging Fixtures**

1. Fixtures should be played on the date selected at the team secretaries meetings. Fixtures are the home teams responsibility. If a home team secretary is struggling to arrange a game, they should contact the league secretary.
2. Home teams will default matches, which are not played before the end of the season.
3. In all cases, the Home team's Secretary should contact the Away team's Secretary to arrange match date, time and venue. This will take place at the Team Secretaries meetings. The League Secretary will be informed of all arranged games. Failure to do so will result in that team defaulting the game or in the case of both teams not informing the League Secretary the match will be declared void.
4. Any team wishing to change an arranged fixture must do so no later than 72 hours before the arranged date and time.
5. Any team failing to arrive to a fixture or cancelling within 72 hours period will default the match and will be fined £30. This money will be paid over to the opposing team. The team being fined must pay the fine before being allowed to play any more games.
6. *Any team postponing a fixture may* not postpone the rearranged fixture. The League Secretary must be informed of any postponed games before the arranged match date, by both teams.
7. In the event of two teams being unable to arrange a fixture:-
  - (i) The League Secretary should be notified.
  - (ii) Disputes Procedure 3 should be followed.

## **8. Results**

- 8a. Results must be recorded on an official H&EYVA scorecard. Please fill in all fields so the league secretary has full information on the match.

- b. Results will not be valid unless the scorecard records:-
- (i) A complete list of each team.
  - (ii) Signature of both captains
  - (i) First referee's name and signature.
    - (ii) Set scores and match score.
    - (iii) Date
9. At the start of the season each team shall receive stamped addressed envelopes to the League Secretary for the return of scorecards on time. The home team is responsible for delivery of the completed scorecard to the League Secretary, who should receive it NO LATER THAN 7 DAYS AFTER THE DATE OF THE MATCH unless the fixture has been postponed. The home team must fill in the results page on the H&EYVA website within 24 hours of the match.
10. If any of the conditions to results (8 and 9 above) are not fulfilled the League Secretary could declare the match void and award 0 points to either side. If the League secretary fails to receive the scorecard within seven days of the match or a copy within fourteen days then the home team will default the match in favour of the away side.

## **B. LEAGUE ORGANISATION**

1. Each team in a division shall normally play each other team twice.
2. Matches shall be played over 5 sets.

### **Points**

- 3a. 3 points shall be awarded for a win, or an awarded match; 1 point shall be awarded for a loss; 0 points are awarded for a void match; 2 points will be deducted for a defaulted match.
- b. Matches shall be awarded if the opposition:-
- (i) Fail to field a full side, including an official if at home.
  - (ii) Fail to attend a fixture.
  - (iii) Fail to give 72 hours notice of postponement of a fixture.
  - (iv) Play unregistered or ineligible players.
- c. In the event of a tie in any division the following criteria will be used to determine the final positions:-
- (i) Least matches lost by default.

- (ii) Most sets scored for.
- (iii) Least sets scored against.
- (iv) Most total points against.
- (v) Least total points against.
- (vi) The results of the matches between the teams.

## **Trophies**

- 4. There will be a medal awarded to the winners of the league
- 5. A team holding a trophy shall be responsible for its upkeep. The engraving of the trophies shall be the responsibility of the H&EYVA
- 6. All trophies must be returned to the Cup/League Secretaries by 1<sup>st</sup> March. Failure to return a trophy will result in a £50 fine per trophy. This fine must be paid over to the H&EYVA before the club/team are accepted into any future H&EYVA organised events.
- 7. Medals will be awarded to each registered member of a division side.

## **Promotion and Relegation**

- 8a. Division winners, below Division 1, qualify for promotion.
- b. Any team wishing to waive the right of promotion should inform the Honorary Secretary with reasons in writing by 1<sup>st</sup> May.
- 9a. Normally the bottom team in a division will be relegated. If applicable.
- b. A team disbanding at any point in the season shall:-
  - (i) Automatically default all outstanding matches.
  - (ii) Be placed at the bottom of the division.
  - (iii) Be withdrawn from the League at the end of the season.
  - (iv) Lose their team deposit.
- 10. Other promotion and relegation shall be at the discretion of the "Executive Committee".

## **CUP COMPETITIONS**

### **A. Competitions and Qualifications**

1. The Open Tournament (Jubilee Tournament) shall be open to:-
  - (i) All H&EYVA registered teams.
  - (ii) Any other Volleyball England registered club that registers with the Cup Secretary and pays the entrance fee. The Organisation of the cup competitions and any additional cups and tournaments can be organised at the discretion of the H&EYVA “Executive Committee”.
2. The H&EYVA Cup shall be open to all H&EYVA registered teams.
3. The H&EYVA Plate shall be open to:-
  - (i) All H&EYVA registered teams.
  - (ii) All teams that are knocked out of the H&EYVA Cup before the semi finals unless there are 7 teams or less in the competition.
4. The Development Cup shall be open to:-
  - (i) Teams playing in the H&EYVA league below Division 1.
  - (ii) Non H&EYVA teams invited by the “Executive Committee” to take part.
5. All players are “cup tied”

### **B. Fixture Procedures**

1. All fixtures must be played no later than 14 days after the date specified in the H&EYVA handbook, unless the Cup Competitions Secretary grants postponement.
2. The home team is responsible for delivery of the completed scorecard to the Cup Competitions Secretary, who should receive it NO LATER THAN 7 DAYS AFTER THE DATE OF THE MATCH unless the fixture has been postponed. Both teams must fill in the results sheet on the website within 24 hours of the match. Results should be posted by the home club on the H&EYVA website [www.heyva.org.uk](http://www.heyva.org.uk) within 24 hours of the game being played. Each club has had provided their own log-in details. This is a very simple procedure. Club captains and secretaries are to ensure that this task is complete. Fixtures secretary and the website manager will check as best as possible.



3. At the end of the 7 day period (rule 2), the fixture will be awarded to the away team unless:-
  - (i) The Cup Competitions Secretary has granted a postponement.
  - (ii) The fixture is in dispute, pending “Executive Committee” ruling providing that they claim the fixture in writing.
4. The home secretary is responsible for arranging the time, date and venue with the away team secretary for all matches up to and including the semi finals.
5. The “Executive Committee” will arrange finals of cup competitions and meet all costs. The dates of the finals will be published in the handbook and are not subject to alteration.

### **C. Officials**

- 1a. At the request of either team the “Executive Committee” will nominate neutral referees for cup competitions before the finals.
- b. The cost of neutral officials provided by the “Executive Committee” for matches before the finals, will be shared by the two teams.
2. The “Executive Committee” will provide and remunerate officials for finals at the following rates. Referees £10; Umpire £10; Scorer £10, plus travel expenses.
3. The two teams competing in the H&EYVA Cup Final will provide two Line Judges each for the H&EYVA Plate Final. The two teams competing in the H&EYVA Plate Final will provide two line judges each for the H&EYVA Cup Final. Failure to do so will result in those teams not providing Line Judges being expelled from all H&EYVA competitions the following season.

### **D. Disputes**

1. Any dispute in a cup competition should be resolved as follows:-  
Both secretaries should:-
  - (i) Inform the Cup Competitions Secretary in writing that there is a dispute.
  - (ii) Send details of the dispute to the Honorary Secretary and to the secretary of the other team in writing.

The disputes will then be resolved as under the general “Disputes Procedure”.

## **HEYVA SUMMER LEAGUE RULES OF COMPETITION**

### **A. Players and Registration**

1. All players must be registered with a H&EYVA registered club (unless organiser agrees otherwise) and paid up members of the H&EYVA Summer League by a date TBC. All clubs secretaries will be informed of the summer league, and given the opportunity to enter.
2. A player may only play for one team in any one season.
3. A team will consist of two players; however a substitute may be named, but can only be played when one player is unavailable.

### **B. Timing of Fixtures**

1. All games will normally be played on a Thursday evening at Baysgarth School, DN18 6AE.
2. Teams must be ready to play at 6:15pm. If a team is not ready to start at this time or fails to turn up they will forfeit those matches.
3. If either team refuses to play due to adverse weather conditions (agreed by organiser) then the game will be played the following week; likewise if a game cannot be completed then the game will be finished the following week.
4. Fixtures and League Tables will be available each week through the HEYVA Facebook Page.
5. All teams will play each other an equal number of times; however if there are enough entries then a divisional system may be introduced. (This has happened for 2013)

### **C. Rules of Play**

1. The Official Beach Volleyball rules shall apply at all times.
2. 2 Points will be awarded for a win; 1 for a loss and 0 for a default.

#### **D. Court and Equipment**

1. Outdoor nets and posts will be provided. Teams will be required to set up their own courts on a regular basis.
2. A match ball will be provided for all games.
3. No shoes with spikes or studs will be allowed.

#### **E. Officials**

1. Teams will be required to referee and score when not playing.
2. All scorecards, ball and equipment must be returned to the organiser at the end of each evening.
3. The referee must record on the score sheet the SPORTSMAN of the match for each game.
4. If there are any disputes then the organisers' decision will be final.
